

RESOLUTION NO. 2006-35
A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LEMOORE RESTRICTING AVAILABILITY OF
SIXTY GALLON CURBSIDE REFUSE CONTAINERS

At a Regular Meeting of the City Council of the Lemoore City Council duly called and held on June 20, 2006, at 7:30 p.m. on said day, it was moved by Councilmember _____, seconded by Councilmember _____ and carried that the following Resolution be adopted:

WHEREAS, the City of Lemoore Public Works Department will begin curbside recycling in October 2006; and

WHEREAS, the use of larger ninety gallon refuse containers will reduce potential cross-contamination between refuse and recycling waste; and

WHEREAS, in accordance with Resolution 2001-22, the sixty gallon refuse containers and disposal service provided at a reduced rate to encourage recycling among residents of the City of Lemoore will no longer be useful for that purpose; and

WHEREAS, significant numbers of residents attempting to make use of the sixty gallon container rate would result in indeterminate fee revenue reductions, resulting in fiscal instability that would make implementation of the curbside recycling program a financial burden on the refuse fund and defeat the integrity of the financial modeling of the program; and

WHEREAS, the City wishes to prevent fee increases for all customers and to standardize service.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lemoore as follows:

1. The Council hereby establishes that customers taking advantage of the sixty gallon container rate as of June 20, 2006, may continue receiving said rate as long as said service continues uninterrupted at the service address. A sixty gallon container that deteriorates beyond serviceability may be replaced with another sixty gallon container while current supplies last, or absent one available, be replaced by a ninety gallon container at the ninety gallon container rate.
2. The Council hereby restricts availability of the sixty gallon container rate to existing sixty gallon container customers as of June 20, 2006, and no longer offer the sixty

gallon container rate to new customers or existing ninety gallon container customers beyond that date.
