

RESOLUTION NO. 2006 - 44

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE
SUPPORTING THE WEST HILLS COMMUNITY COLLEGE DISTRICT
SCHOOL BOND MEASURE W**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on October 3rd, 2006 at 7:30 p.m. on said day, it was moved by Councilmember _____, seconded by Councilmember _____, and carried, that the following Resolution be adopted:

WHEREAS, West Hills Community College District has established itself as a vibrant and growing institution not only on the Lemoore campus, but in Coalinga and Firebaugh as well; and

WHEREAS, the City of Lemoore, in particular, is growing at an outstanding rate and our West Hills College, Lemoore campus will need to continue to expand and grow to keep pace with the community that surrounds it and the needs of its constituents; and

WHEREAS, the Board and Administration at West Hills Community College District have worked diligently to get bond Measure W on the local ballot for the election that will take place in November, 2006; and

WHEREAS, members of the campaign committee have solicited support, and rightfully so, from the Council of the City of Lemoore, in an effort that will hopefully bring about a successful result in November and provide West Hills Community College District with a new bond worth \$35 million in local funding; and

WHEREAS, these new local funds will also bring in State matching funds that will allow the District to finish their plans, which include a Child Development Center, a new Gymnasium, and expanded classroom space; and

WHEREAS, it is certainly true that West Hills College will continue to provide local residents with the highest quality of education and training and will thereby add to our economy by supplying the future workforce – an invaluable service to the community.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lemoore that we hereby express strong support for Measure W, the local bond measure that will provide funding for West Hills Community College District.
