

RESOLUTION NO. 2007-14

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE
RESCINDING RESOLUTION 2007-06 AND ADOPTING A NEW RESOLUTION TO
AMEND THE MASTER USER FEE SCHEDULE TO REFLECT THE ANNUAL
UPDATE RELATED TO THE EMPLOYMENT COST INDEX FOR THE PERIOD
ENDING DECEMBER 31, 2006**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on April 17, 2007 at 7:30 p.m. on said day, it was moved by Councilmember _____ and seconded by Councilmember _____ and carried that the following Resolution be adopted:

WHEREAS Government Code Sections 66012 – 66018.5 grants to the City Council of the City of Lemoore the authority to establish and charge User Fees in connection with certain public services that are provided to businesses and individuals; and

WHEREAS the City Council has the authority to increase certain fees annually, based on the nationally published Employee Cost Index for State and Local Governments or by reevaluation and assignment of actual municipal costs; and

WHEREAS the ECI increase for the period ending December 31, 2006 was fixed at 4.1%, therefore certain fees in the Master User Fee Schedule that are directly connected to employee costs can rightfully be increased by 4.1% annually; and,

WHEREAS certain fees, including PUD Single Lot Review and Animal Control were evaluated and new fees were determined and set. Additionally, the Alcoholic Beverage Control review fee (set by Resolution No. 9605) was added to the schedule; and,

WHEREAS the City of Lemoore, at the Regular Meeting held on March 6th, 2007 adopted Resolution 2007-06 without proper notice to a certain requesting party, and therefore did not meet the requirements pursuant to Government Code Section 66016 and finds that it needs to rescind Resolution 2007-06.

WHEREAS the City of Lemoore has now met the requirements pursuant to Government Code Section 66016 by noticing said requesting party and holding a public hearing concerning the adoption of said fees and has made those fees accessible to the public through local postings.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lemoore that:

1. That Council does rescind Resolution 2006-07; and,
2. The Council finds that the specific amount of the updated user fees, the description of the benefit and impact area on which the user fee is imposed, the description of the reasonable relationship between the fees and the various types of services, and the time

for payment set forth below in this resolution are proper and necessary and the information and data upon which the fees are based is correct and accurate; and,

3. Council hereby adopts and approves the Master User Fee Schedule updated for 2007, following a public hearing on the matter and the same is incorporated herein; and,
4. Pursuant to California Government Code Section 66017, the fees adopted by this resolution shall be in full force and effect and shall be collected beginning July 1, 2007; and,
5. Once adopted, Council acknowledges that any user fees previously determined by Resolution or other fashion will be replaced by the user fees outlined in the Fee Schedule contained herein.
6. Any judicial action or proceeding to attack, review, set aside or annul this resolution shall be brought within 120 days of its adoption; and,
7. The specific amount of User Fees, as Amended, are set forth in the table below:
