

RESOLUTION NO. 2007-44

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LEMOORE AMENDING RESOLUTION 2007-17
REGARDING UNDERGROUND UTILITY DISTRICT NO. 0301-A**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on November 6, 2007, at 7:30 p.m. on said day, it was moved by Councilmember _____, seconded by Councilmember _____ and duly carried that the following Resolution be adopted:

WHEREAS, on June 1, 2004, the City Council of the City of Lemoore adopted Resolution No. 2004-30 (Exhibit A) establishing Underground Utility District No. 0301-A for the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communications or similar or associated services in the area in the City of Lemoore; and

WHEREAS, on June 5, 2007, the City Council of the City of Lemoore adopted Resolution No. 2007-17 amending Resolution No. 2004-30;

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Lemoore hereby amends the dates that all poles, overhead wires and associated structures shall be removed and underground installations made in said City of Lemoore Underground Utility District No. 0301-A as follows:

- A. Trenching, conduit and cable installation no later than December 31, 2008.
- B. Paneled conversions by affected property owners no later than March 31, 2009.
- C. Removal of poles, overhead wires and other associated structures no later than May 31, 2009.

BE IT FURTHER RESOLVED that the City Clerk shall within ten (10) days after the effective date of this Resolution mail a copy thereof as required by Section 7-6-4 of the Municipal Code of the City of Lemoore to all affected Utilities and all persons owning real property within the boundaries of the City of Lemoore Underground Utility District No. 0301-A created by this Resolution.
