

**RESOLUTION NO. 2008-21**

**A RESOLUTION OF THE CITY OF LEMOORE ADOPTING A “NOTICE UNDER THE AMERICANS WITH DISABILITIES ACT” AND ADOPTING THE “CITY OF LEMOORE GRIEVANCE PROCEDURE UNDER THE AMERICANS WITH DISABILITIES ACT”**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on April 1, 2008 at 7:30 p.m. on said day, it was moved by Council Member \_\_\_\_\_, seconded by Council Member \_\_\_\_\_ and carried that the following Resolution be adopted:

**WHEREAS**, the Americans with Disabilities Act of 1990 (ADA) 42 U.S.C. Section 12101 et. seq. became effective on January 26, 1992 ; and

**WHEREAS**, access to civic life is a fundamental goal of the Americans with Disabilities Act; and

**WHEREAS**, Title II of the ADA (42 U.S.C. Section 12132; 28 C.F.R. Section 35.130) requires state and local governments to make their programs, services, and activities accessible to persons with disabilities and to provide Grievance Procedures by which alleged discrimination on the basis of disability may be addressed; and

**WHEREAS**, the accessibility requirements apply not only to physical access at government facilities, programs, and events, but also to policy changes that governmental entities must make to ensure that persons with disabilities can take part in, and benefit from, the programs and services of state and local governments; and

**WHEREAS**, it is in the interest of both the City and qualified individuals with disabilities that all persons accessing City programs, services, and activities be made aware that the foresaid be provide free from discrimination based on disability or perceived disability; and

**WHEREAS**, the City of Lemoore is committed to meet the requirements of Title II of the ADA.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Lemoore hereby approves the *Notice under the Americans with Disabilities Act* (Exhibit A) and the *City of Lemoore Grievance Procedure under the Americans with Disabilities Act* (Exhibit B), and directs the City Clerk to permanently post both in a well-traveled location within City Hall accessible to persons with disabilities, and to post additional copies as deemed necessary by the ADA Coordinator of the City of Lemoore in keeping with compliance to the Americans with Disabilities Act of 1990.
