**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE
ASSIGNING A STREET NAME TO NEW STREET ACCEPTED BY THE CITY OF LEMOORE
ON JANUARY 19, 2010, RECORDED ON JANUARY 22, 2010 IN
KINGS COUNTY RECORDER’S DOCUMENT #1001232**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on October 5, 2010 at 7:30 p.m. on said day, it was moved by Council Member _____, seconded by Council Member _____ and carried that the following Resolution be adopted:

WHEREAS, the City Council accepted a new north-south street located east of the current Fresh-n-Easy, south of the new St. Peter’s church, connecting to Cinnamon Drive, at its January 19, 2010 meeting and recorded the Irrevocable Offer of Dedication on January 22, 2010 through document # 1001232 in the Kings County Recorder’s Office; and

WHEREAS, a street name was not assigned at the time of acceptance of the above street dedication; and

WHEREAS, several proposed street names have been submitted to the City for consideration; and

WHEREAS, the California Government Code Section 34091.1 states that “whenever the legislative body finds that a name should be adopted and applied to any city street, or that the existing name of any city street should be changed, the legislative body may adopt a resolution designating a name for, or change the name of, such street”

WHEREAS, there is no requirement to hold a public hearing or provide notices, and

NOW, THEREFORE, BE IT RESOLVED after listening to various options, the City Council of the City of Lemoore does hereby assign _____ as the new street name for the above mentioned street, as shown on the attached Exhibit Map A-1.
