RESOLUTION #2008-14

**A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LEMOORE
DETERMINING THAT THE PROPOSED VACATION OF SARA DRIVE/SPRING LANE WALKWAY
IS NOT CONFORMANCE WITH THE LEMOORE GENERAL PLAN**

At a Regular Meeting of the Planning Commission of the City of Lemoore duly called and held on June 9, 2008, at 7:00 p.m. on said day, it was moved by Commissioner _____, seconded by Commissioner _____ and carried that the following Resolution be adopted:

WHEREAS, the Council of the City of Lemoore on May 6, 2008 passed Resolution 2008-24 declaring its intention to abandon the dead-end stub street called Sara Drive/Spring Lane walkway located to the north of the Park Place Apartment complex's wall and more particularly shown and described on the attached legal descriptions and maps on file in the office of the City Clerk and attached hereto as Exhibits A1, B1, A2, and B2.

WHEREAS, pursuant to Government Code Section 65402, the Council submitted its intent to vacate the dead-end street known as Sara Drive/Spring Lane walkway to the Planning Commission to determine its conformity with the Lemoore General Plan; and

WHEREAS, utility companies have been contacted as part of the abandonment process to confirm if there are any other outstanding utility issues;

WHEREAS, the Planning Commission reviewed the Sara Drive/Spring Lane walkway abandonment, as shown on the attached Exhibits A1, B1, A2, and B2 in its meeting on June 9, 2008, to determine its conformity with the Lemoore General Plan; and

NOW THEREFORE, BE IT RESOLVED that the Planning Commission of the City of Lemoore does determine that the dead-end stub street known as Sara Drive/Spring Lane Walkway shown more particularly on Exhibits A1, B1, A2, and B2 is in conflict with the Lemoore General Plan.
