

RESOLUTION NO. 2008-17

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LEMOORE DETERMINING THAT THE CITY'S 2008-2010 CAPITAL IMPROVEMENT PROGRAM BUDGET IS GENERALLY IN CONFORMANCE WITH THE LEMOORE GENERAL PLAN AS PER GOVERNMENT CODE 65401 WITH EXCEPTIONS DISCUSSED BELOW

At the Regular Meeting of the Planning Commission of the City of Lemoore duly called and held on October 13, 2008, at 7:00 p.m. on said day, it was moved by Commissioner _____, seconded by Commissioner _____ and carried that the following Resolution be adopted:

WHEREAS, pursuant to Government Code Section 65401, the Planning Commission must make a determination that improvement program budgets are in conformance with the Lemoore General Plan; and

WHEREAS, Bi-annually the City Council adopts a Capital Improvement Program Budget; and

WHEREAS, City staff reviewed all pertinent General Plan policies to insure that the aforementioned budgets were in conformance with the Lemoore General Plan as stated in the Government Code Section 65401 and determined that The Fiscal Year 2008 – 2010 Capital Improvement Program Budget is generally in conformance with the existing Lemoore General Plan with the exception of the following:

- 1) The portion of Item #1 under the "Buildings" activity summary section does not conform with the 2030 General Plan in regards to removing the historic windows and should be removed from the project to conform with the General Plan.
- 2) Item #4 under the "Streets" activity summary section does not conform with the 2030 General Plan. The signal projects that should be included here from Item #6 should be Cinnamon Drive and 19th Avenue and Bush Street and 19½ Avenue while retaining Bush Street and Belle Haven and removing the rest to conform with the General Plan.
- 3) Item #6 under the "Streets" activity summary section does not conform with the 2030 General Plan. The Traffic Signal / Roundabout Installations should include Hanford-Armona Road and Fox/Antelope and Bush Street and 19th Avenue from Item #4 while keeping Cinnamon Drive and Fox Street and removing the rest to conform with the General Plan

NOW, THEREFORE, BE IT RESOLVED that the Planning Commission of the City of Lemoore does determine that the 2008/10 Capital Improvement Program budget is generally in conformance with the 2030 Lemoore General Plan with the exception of the three (3) line items discussed above which should be modified by the City Council before its final adoption.
