

**RESOLUTION #2010-04**

**A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LEMOORE  
DETERMINING THAT THE PROPOSED ABANDONMENT OF EXISTING  
PUBLIC UTILITY EASEMENT WITHIN A PORTION OF THE PREVIOUSLY ABANDONED  
HILL STREET IS IN CONFORMITY WITH THE LEMOORE GENERAL PLAN**

At a Special Meeting of the Planning Commission of the City of Lemoore duly called and held on February 23, 2010, at 7:00 p.m. on said day, it was moved by Commissioner \_\_\_\_\_, seconded by Commissioner \_\_\_\_\_ and carried that the following Resolution be adopted:

**WHEREAS**, the Council of the City of Lemoore on February 16, 2010 passed Resolution 2010-04 declaring its intention to abandon portions of a public utility easement located within a portion of the previously abandoned Hill Street south of "G" Street within Leprino's east plant as described on the attached legal description and shown on the attached map to be replaced by a new public utility easement; and

**WHEREAS**, pursuant to Government Code Section 65402, the Council submitted it's intent to vacate a portion of the Public Utility Easement to the Planning Commission to determine its conformity with the Lemoore General Plan; and

**WHEREAS**, utility companies have been contacted as part of the abandonment process to confirm if there are any other outstanding utility issues;

**WHEREAS**, the Planning Commission reviewed the Public Utility Easement abandonment, as shown on the attached documents in its meeting on February 23, 2010, to determine its conformity with the Lemoore General Plan; and

**NOW THEREFORE, BE IT RESOLVED** that the Planning Commission of the City of Lemoore does determine that the abandonment of the Public Utility Easement as shown in the attached legal description and map is not in conflict with the Lemoore General Plan and therefore finds that the abandonment is in conformity with the Lemoore General Plan.
